

Summer Camp 2025: Frequently Asked Questions

Program Dates: June 16th-August 15th, 2025

We will be closed the week of August 18th to prepare for fall sports programs and School's Out after care services. The ability to offer additional services for the end of August will be determined by staff availability and the school calendar for 2025-2026. We have not offered expanded weeks for several seasons; it is recommended to plan in advance for any childcare needs following the conclusion of our summer programs.

Program Hours:

• K-8 Summer Camp hours are 7:30am-5:30pm

Enrollment limits: programs may be limited as we open enrollments. If group maximums are expanded and we have the ability to add additional seats in the summer, we will do so. Camps that in the past have had larger enrollments will have a wait list.

Program Locations: locations are planned as follows for summer 2024:

Grades K-1 Camp: Saco Community Center

Grades 2-3 Camp: Fairfield School Gymnasium and stage **Grades 4-5 Camp:** Burns School Gymnasium and cafeteria

Grades 6-8 Camp: Saco Community Center

Meals: The Saco School Nutrition Program Free Breakfast and Lunch are typically available to all children ages 18 and under at all sites through early August. Menus may be available during the summer months and will be sent to families once we receive them. For snacks, each day at camp typically has two snack breaks, and these should be sent from home as they are not provided through the meal program.

Summer Camp Format: This summer, we will offer creative and fun on-camp activities along with community outings/local field trips and on-camp entertainment events.

Monthly Field Trip and Activity Schedules:

• **Summer Camp:** we will be working on activity and trip schedules leading up to camp. Typically, the week before camp starts, we will send an informational update about schedules and preparation for camp (what to bring, check-in and check-out procedures, etc.). Monthly camp schedules will be available throughout the summer. Because many of the businesses we work with are seasonal and open for the summer around the start of May, we do not anticipate having trip schedules available earlier than mid-June. We understand many families plan camp registrations based on the activity calendars and thank you in advance for your understanding about the timing of our information.

• School Summer Learning: we will work with the Saco School Department this spring as they develop plans for summer learning with the goal of supporting these efforts with our camp schedules. Parents should notify the SPR Main office with their campers summer school information which should include: dates, times and transportation information for their child's program. *It is important to note that while we try to work around the summer learning program in regard to field trips, there are occasions where they will interfere with each other. We do not leave staff behind so parents will need to make a choice on either skipping summer learning or making alternate arrangements for their camper in the event of a conflict. *

Daily Payment Option to register for summer camp: we are only offering weekly and full summer payment options this year; we will not be adding a daily registration option.

Program Shirts: participants will receive 1 camp shirt this year. Shirts will be available to pick-up at camp. Additional shirts will be available for purchase with the SPR Main office after camp starts.

Emergency medications: for campers who require emergency medications such as inhalers or EpiPens, these will be turned in to the SPR Office during the week of June 9th. Deadline is Thursday, June 12th.

Fee Waivers: the fee waiver application for 2025-2026 programs will be available in March 2025 at www.sacorec.com under "Department Info-Forms". Completed applications and supporting materials can be submitted in person at the SPR Main Office or via mail to "Attn: Ryan Sommer, Saco Community Center, 75 Franklin St., Saco ME 04072". Cancellations: Refunds and Credits

- In the event of program postponement or cancellation by Saco Parks and Recreation, all registration fees will be eligible for a full credit or refund.
- **Full Summer Camp registrations:** those that enroll at the Full Summer rate may cancel their enrollment or transfer to a weekly format through Friday, June 6th, 2025. *Full summer enrollments with a remaining balance after June 6th will automatically be converted to the weekly option during the week of June 9th unless the balance is paid in full. The deposit paid will be applied to your account as credit.*
- **Weekly registrations:** these registrations may be cancelled by 3:00pm on Thursday preceding the registered week to be eligible for a refund or credit. Any cancellations made within the registered week are eligible for 50% credit only, as long as no dates have already been attended.
- Refund policies:
 - All credit card refunds are subject to a 5% processing fee.
 - We are not able to provide a refund for any last-minute cancellations or illnesses this season. See above for credit options for weekly and theater cancellations.
